### HEAVYWEIGHT

TYSON FURY (Champion, England) v DAVID PRICE (England)

The BBB of C has called for purse offers to be submitted to their offices in Cardiff, Wales by 12 noon, Wednesday, 8th February 2012, such offers to be submitted in accordance with BBB of C Rules and Regulations (see website [www.bbbofc.com](http://www.bbbofc.com)). This mandatory defence of the British Title will also be a mandatory defence of the Commonwealth Title, in accordance with the decision of the CBC of 8th December 2011.

### LIGHTMIDDLEWEIGHT

JAMIE COX (Champion, England) v OBODAI SAI (Ghana)

The CBC is calling for purse bids to be submitted for this mandatory defence, to be submitted to the Chairman, Philip Brook Smith QC by no later than 12 00 MIDDAY,(British time) FRIDAY 17TH FEBRUARY 2012 in accordance with the Notice of 9th February 2010 'Terms of purse bids for Commonwealth Championships' see [www.commboxing.com](http://www.commboxing.com), click on 'NOTICES' and download.

In addition :-

1. The contest must take place by the end of April 2012. The CBC may permit a small extension provided that that promoter concerned has notified the Hon Secretary prior to 5 00pm (British time) Monday 13th February

2. Unless both boxers agree, the contest shall not take place prior to Friday 16th March 2012

3. Purse bids must be submitted in accordance with CBC Terms, as advised above, in sealed envelopes clearly marked on the outside 'PO JC/OS'. Purse bids must be received by post, carrier or in person before the 12 midday deadline. Any bid received after this will be disallowed. Any promoter or representative attending in person will be permitted to attend the opening of bids.
