### COMMONWEALTH SUPERBANTAMWEIGHT CHAMPIONSHIP

Following the dismissal of the appeal by Champion KID GALAHAD (England) against a decision of the UK Anti-Doping Agency to suspend his BBB of C Boxer's Licence, and with the suspension applying until 19<sup>th</sup> September 2016, the Directors of the CBC have declared the Superbantamweight Championship vacant forthwith.

The Directors will approve the best match proposed by any promoter between 2 approved challengers, in accordance with usual CBC formalities, as being for the vacant Title.

### VACANT HEAVY AND FLY TITLES

Undefeated Heavyweight prospects ANTHONY JOSHUA and GARY CORNISH meet for the vacant Heavyweight Championship in London on 12<sup>th</sup> September.

A week earlier (subject to final confirmation of date), THOMAS ASOMBA seeks to become Cameroon's first Commonwealth Champion when he meets WALEED DIN in Rotherham for the vacant Flyweight Championship
