4. EACH CONTEST SHOULD TAKE PLACE BEFORE THE END OF SEPTEMBER 2009. ANY PROMOTER REQUESTING AN EXTENSION MUST CONTACT THE HON. SECRETARY IN GOOD TIME BEFORE THE OPENING OF BIDS
